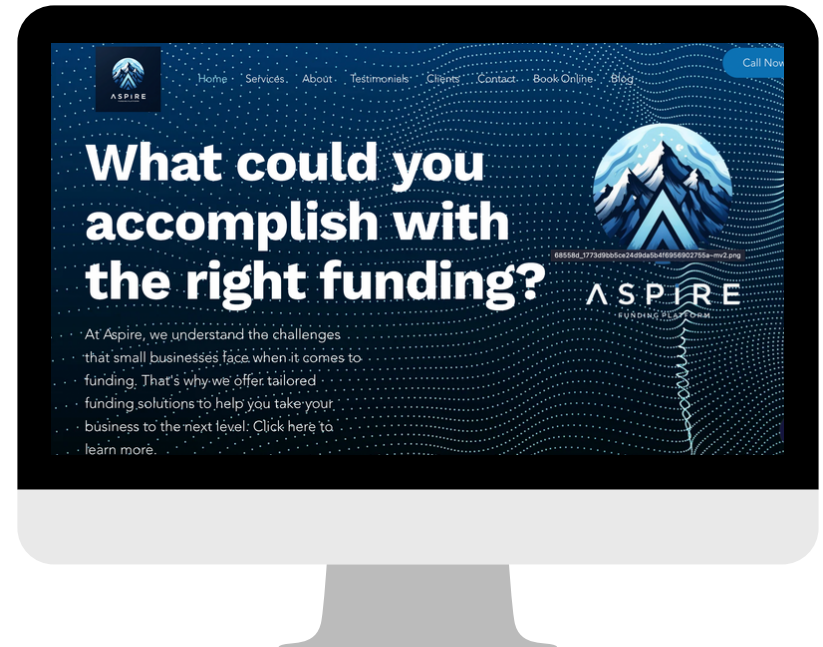

Funding Parameters	3 - 12 months
Funding Amount	\$10,000 - \$1,000,000
Remittance	Daily, Weekly

Required Documentation for Underwriting

Last three months' bank statements
Outstanding balance, associated funder, and daily or weekly debit amount of cash advances
Signed and dated application with approved credit authorization

Category

Criteria

Owner FICO Score	≥ 500
Time In Business	≥ 9 months
Annual Revenue	$\geq \$100,000$
Avg. Monthly Deposits	≥ 3 revenue deposits
Avg. Daily Balance	$\geq \$1,000$
Max NSF's per Month	6
Bankruptcies	Must be closed
Tax Liens	$\leq \$100,000$ or must be on a payment plan
Consolidation	Limited, based on risk score, can pay off up to two positions
